STATE ACTION ON BUSINESS ENABLING REFORM ORDER I 2023

In the exercise of the powers conferred upon me by Section 5(2) of the Constitution of the Federal Republic of Nigeria 1999 (as amended) and all other powers enabling me in that behalf, I, Malam Dikko Umaru Radda, Ph.D., Governor of Katsina State, do order as follows:

1. This Order may be cited as the State Action on Business enabling Reform Order I and shall be deemed to come into effect on the^{22nd}..... day of^{Dec}..... 2023.
